In order to process your fuel taxes, T.F.I.G will need to know how many miles you traveled in each state during each period. T.F.I.G will also need to know the gallons of fuel you purchased in each state during each period. This can be calculated with log books and fuel receipts or with trip sheets. The trip sheets must list each state traveled in along with the beginning and ending odometer readings. It must include the number of gallons of fuel purchased in each state. The trip sheets are the most accurate method. We have standard blank trip sheets available if you need one to get started.

If you are doing trip sheets, you may fax those to 770-228-4242. T.F.I.G's fee for doing your fuel taxes is \$70.00 for the first truck/driver and \$35.00 for each additional truck/driver per quarter. If the documents that you submit are not organized, there will be an extra \$25.00 charge per truck/driver. When you send your first quarter for T.F.I.G to do, we will need to know your KYU#, New Mexico WDT#, NY HUT, and copy of your IFTA license. Also T.F.I.G will need to know your contact information. T.F.I.G also needs a signed, dated, and notarized Power of Attorney before any work is started. This enables T.F.I.G to contact the states offices on your behalf.
