## LIMITED POWER OF ATTORNEY

- IV. My Attorney-in-Fact shall be compensated based upon the fee schedule provided to Grantor and the Attorney-in-Fact, and all payments shall be made to Attorney-in-Fact in advance.
- V. All actions taken by Attorney-in-Fact on behalf of the Grantor shall be based upon information provided by Grantor, and the Attorney-in-Fact is hereby indemnified and held harmless by Grantor as to Attorney-in-Fact's reliance on any information provided by Grantor.
- VI. The Power of Attorney shall continue in full force and effect until revoked by subsequent writing. Further, this Power of Attorney revokes all other Powers of Attorney executed by Grantor prior to the date of this Power of Attorney.

This instrument is to be construed and interpreted as a durable Power of Attorney. This durable Power of Attorney shall not be affected by disability of the principal, except as provided by statute.
